- Location** 8956 Research Blvd., Austin, TX 78758. If you're coming north on 183, exit Burnet and go to the stoplight (don't do the loop-under). Turn left at Burnet and take another left on the 183 frontage road now going south. Look for the Right Space Storage sign on your right. The club is inside Storage. Drive passed the office building and up to the main gate. The club is located in the east side of the storage facility by the rail road tracks.
- Equipment** 16 I.T.T.F. approved Butterfly Centerfold 25 tables, white 3-Star 40+ Nittaku premium plastic balls. Only USATT approved equipment will be used.
- Clothing** The USATT dress code applies. The primary color of shirts/shorts/skirts must be significantly different from the color of the balls used (white). Non-marking rubber soled shoes must be worn.
- Rules** All USATT regulations apply. Matches will be best of 5, 11 point games. Latest rating as of the deadline date will be used for the tournament rating.
- Eligibility** Open to all members of USATT or others. New USATT fees are as follows:

- *Or purchase a tournament pass for \$20/per tournament, no limit for non-USATT members*
- Format:** This is a 1-day and two-star USATT sanctioned tournament, hosted by the Austin Table Tennis Association. Total cash prize is \$1450. Two phase round robin with A-F divisions. Preliminary round robin groups will be played to determine singles divisions. The top finisher in each round robin group will advance to the A group, second place finisher will advance to the B group, etc (all players play phases one and two). Second phase will feature two round robin groups in each division. In the final phase, the single knock out round will be used with cross over matches then winners meet for finals and losers meet for 3-4 placement. Cash prize events have to be played and completed to earn the money.
- Reporting** Players must register at the control desk by 8:30 am.
- Practice** The facility will be open on Friday, April 27 for practice from 6pm to 10pm.
